LEMON SLICE

Get into the festive season this Christmas with this quick, easy and delicious recipe to serve to your loved ones.

INGREDIENTS

- 1/2 cup butter
- 1/2 cup sweetened condensed milk
- 1 lemon, juiced and zested
- 1 1/2 cups tea biscuits, crushed
- 1 cup flaked coconut

DIRECTIONS

- 1. In a small saucepan over medium heat, melt together butter and sweetened condensed milk, stirring frequently until smooth.
- Stir in crushed biscuits, lemon juice and zest, and coconut; mix well.
- 3. Press into a 9x9 inch dish.
- 4. Refrigerate overnight before slicing or the squares will come out sticky.
